

CCTV Policy

Kids Club Ely Ltd uses closed circuit television (CCTV) images for the prevention, identification and reduction of crime and to monitor the club's buildings in order to provide a safe and secure environment for children, staff and visitors, and to prevent the loss or damage to club property.

CCTV surveillance at Kids Club Ely Ltd is intended for the purposes of:

- protecting Kids Club Ely Ltd's buildings and assets, both during and after opening hours;
- promoting the health and safety of staff, children and visitors;
- reducing the incidence of crime and anti-social behaviour (including theft and vandalism);
- supporting the Police in a bid to deter and detect crime;
- assisting in identifying, apprehending and prosecuting offenders; and
- ensuring that rules are respected so that Kids Club Ely Ltd can be properly managed.

The system comprises of two cameras at the site positioned on the outside of the office covering the front door, access gate and car park.

The CCTV system is owned and operated by Kids Club Ely Ltd and the deployment of which is determined by the Company Directors. The CCTV is a standalone system and operated by the Company Directors.

The CCTV is monitored by Company Directors via an app which connects directly to the cameras.

Kids Club Ely's CCTV Scheme is registered with the Information Commissioner under the terms of the Data Protection Act. This policy outlines Kids Club Ely's use of CCTV and how it complies with the Act.

All authorised operators (Company Directors, Ann Turner and Cathy Price) with access to images are aware of the procedures that need to be followed when accessing the recorded images. All operators are trained in their responsibilities under the CCTV Code of Practice. All employees are aware of the restrictions in relation to access to, and disclosure of, recorded images.

Kids Club Ely Ltd complies with Information Commissioner's Office (ICO) CCTV Code of Practice to ensure it is used responsibly and safeguards both trust and confidence in its continued use.

The use of the CCTV system will be conducted in a professional, ethical and legal manner and any diversion of the use of CCTV security technologies for other purposes is prohibited by this policy e.g. CCTV will not be used for monitoring employee performance.

CCTV monitoring of public areas for security purposes will be conducted in a manner consistent with all existing policies adopted by Kids Club Ely Ltd, including Equality & Diversity Policy, Staff and Employment Policy, Codes of Practice for dealing with complaints of Bullying & Harassment and Sexual Harassment and other relevant policies, including the provisions set down in equality and other educational and related legislation.

Justification for Use of CCTV

The use of CCTV to control the front door, access gate and car park. for security purposes has been deemed to be justified by the Management and Company Directors. The system is intended to capture images of intruders or of individuals damaging property or removing goods without authorisation or of antisocial behaviour.

CCTV systems will not be used to monitor activity inside the building.

Data Protection Impact Assessments

Where new CCTV systems or cameras are to be installed, Kids Club Ely Ltd will carry out a full Data Protection Impact Assessment identifying risks related to the installation and ensuring full compliance with data protection legislation. This may involve the need for consultation with staff, parents and local residents.

Where existing CCTV systems are in operation as of July 2021, Kids Club Ely Ltd will endeavour to carry out a full Data Protection Impact Assessment on any upgrade or replacement of the system or within a 3 year period from the date of the implementation of GDPR, whichever is sooner.

Location of Cameras

Cameras will be sited so they only capture images relevant to the purposes for which they are installed and care will be taken to ensure that reasonable privacy expectations are not violated.

Kids Club Ely Ltd will ensure that the location of equipment is carefully considered to ensure that images captured comply with the Data Protection Act. We will make every effort to position cameras so that their coverage is restricted to the club's premises.

CCTV will not be used in the community room.

Use of CCTV to monitor areas where individuals would have a reasonable expectation of privacy would be difficult to justify. Kids Club Ely Ltd has endeavoured to select locations for

the installation of CCTV cameras which are least intrusive to protect the privacy of individuals.

Cameras placed so as to record external areas are positioned in such a way as to prevent or minimise recording of passers-by or of another person's private property.

CCTV Video Monitoring and Recording of Public Areas may take place for the following purposes:

- **Protection of Kids Club Ely's buildings and property:** The building's perimeter, the front door, access gate and car park, receiving areas for goods/services
- Monitoring of Access Control Systems: Monitor and record restricted access areas at entrances to buildings and other areas
- Verification of Security Alarms: Intrusion alarms, exit door controls, external alarms
- Video Patrol of Public Areas: Parking areas, Main entrance/exit gates, Traffic Control
- Criminal Investigations (carried out by police): Robbery, burglary and theft surveillance

Covert Surveillance

Kids Club Ely Ltd will not engage in covert surveillance.

Notification

A copy of this CCTV Policy will be provided on request to staff, parents and visitors to the school, a copy will be available in our policy folder in the foyer and will be made available on our website.

The location of CCTV cameras will also be indicated and adequate signage will be placed at each location in which a CCTV camera(s) is sited to indicate that CCTV is in operation.

Appropriate signage will also be prominently displayed so that staff, parents and visitors are aware they are entering an area covered by CCTV.

Storage and Retention

The images captured by the CCTV system will be retained for a maximum of 42 days, except where the image identifies an issue and is retained specifically in the context of an investigation/prosecution of that issue.

The images/recordings will be stored in a secure app with a log of access kept.

Access will be restricted to authorised personnel. Supervising the access and maintenance of the CCTV System is the responsibility of the Company Directors.

When CCTV recordings are being viewed, access will be limited to authorised individuals on a need-to-know basis.

Access

Recorded footage will be securely stored in a restricted app. Unauthorised access will not be permitted at any time. A log of access to footage will be maintained.

Access to the CCTV system and stored images will be restricted to authorised personnel only.

A record of the date of any disclosure request along with details of who the information has been provided to (the name of the person and the organisation they represent), why they required it and how the request was dealt with will be made and kept, in case of challenge.

Data will be provided to those requests authorised in a permanent format where possible. If this is not possible the data subject will be offered the opportunity to view the footage.

In relevant circumstances, CCTV footage may be accessed:

- By the police where Kids Club Ely Ltd (or its agents) are required by law to make a report regarding the commission of a suspected crime; or
- Following a request by the police when a crime or suspected crime has taken place and/or when it is suspected that illegal/anti-social behaviour is taking place on Kids Club Ely Ltdl's property, or
- To the HSE and/or any other statutory body charged with child safeguarding; or
- To data subjects (or their legal representatives), pursuant to a Subject Access Request or
- To individuals (or their legal representatives) subject to a court order.
- To Kids Club Ely Ltd.'s insurance company where the insurance company requires same in order to pursue a claim for damage done to the insured property.

Subject Access Requests (SAR)

Individuals have the right to request access to CCTV footage relating to themselves under the Data Protection Act.

Individuals submitting requests for access will be asked to provide sufficient information to enable the footage relating to them to be identified. For example, date, time and location.

Kids Club Ely Ltd will respond to requests within 30 calendar days of receiving the request in line with the right of access policy.

Kids Club Ely Ltd reserves the right to refuse access to CCTV footage where this would prejudice the legal rights of other individuals or jeopardise an on-going investigation.

A record of the date of the disclosure along with details of who the information has been provided to (the name of the person and the organisation they represent) and why they required it will be made.

In giving a person a copy of their data, Kids Club Ely Ltd provide a still/series of still pictures, a tape or a disk with relevant images. However, other images of other individuals will be obscured before the data is released.

Where footage contains images relating to 3rd parties, Kids Club Ely Ltd will take appropriate steps to mask and protect the identities of those individuals.

Complaints

Complaints and enquiries about the operation of CCTV within Kids Club Ely Ltd should be directed to the Company Directors in the first instance.

Staff Training

Staff authorised to access the CCTV system will be trained to comply with this policy. Staff will understand that all information relating to the CCTV images must be handled securely.

Staff will receive appropriate training to enable them to identify and handle different requests according to regulations.

Staff misuse of surveillance system information will lead to disciplinary proceedings.

Responsibilities

The Company Directors will:

- Ensure that the use of CCTV systems is implemented in accordance with the policy set down by Kids Club Ely Ltd .
- Oversee and co-ordinate the use of CCTV monitoring for safety and security purposes within Kids Club Ely Ltd
- Ensure that all existing CCTV monitoring systems will be evaluated for compliance with this policy
- Ensure that the CCTV monitoring at Kids Club Ely Ltd is consistent with the highest standards and protections
- Review camera locations and be responsible for the release of any information or recorded CCTV materials stored in compliance with this policy
- Maintain a record of access (e.g. an access log) to or the release of tapes or any material recorded or stored in the system
- Ensure that monitoring recorded tapes are not duplicated for release

- Ensure that the perimeter of view from fixed location cameras conforms to this policy.
- Give consideration to both parents and staff feedback/complaints regarding possible invasion of privacy or confidentiality due to the location of a particular CCTV camera or associated equipment
- Ensure that all areas being monitored are not in breach of an enhanced expectation of the privacy of individuals within Kids Club Ely Ltd and be mindful that no such infringement is likely to take place
- Co-operate with the Health & Safety Officer of Kids Club Ely Ltd in reporting on the CCTV system in operation in the school
- Ensure that external cameras are non-intrusive in terms of their positions and views of neighbouring residential housing and comply with the principle of "Reasonable Expectation of Privacy"
- Ensure that monitoring footage are stored in a secure place with access by authorised personnel only
- Ensure that images recorded on digital recordings are stored for a period not longer than <u>28 days</u> and are then erased unless required as part of a criminal investigation or court proceedings (criminal or civil).
- Ensure that when a zoom facility on a camera is being used, there is a second person present with the operator of the camera to guarantee that there is no unwarranted invasion of privacy
- Ensure that camera control is solely to monitor suspicious behaviour, criminal damage etc. and not to monitor individual characteristics
- Ensure that camera control is not infringing an individual's reasonable expectation of privacy in public areas.
